# Information and Application to the Century II Church Planters Fund



#### Philosophy

This program supports the church that has established its viability through a positive growth pattern. The growth pattern is reflected in the church's numeric history, plan for ministry, purpose statement, and a vision or mission statement. The funds available are provided to assist and encourage successful church plants and church revitalization. Applications are reviewed by the General Board of Evangelism and approved or disapproved according to their assessment of the information provided.

### Requirements

- 1. Statement of purpose for the church with the date it was adopted.
- 2. A consensus on the part of the leadership of God's direction in establishing an Evangelical Methodist Church.
- 3. A plan for community outreach—letting the community know you exist.
- 4. Attendance figures for the previous six months that demonstrate measurable growth.
- 5. A signed affiliation with the denomination.
- 6. Agreement by the church planter/pastor to attend a church planting seminar.

#### **General Information**

Approved applicants will receive a total of \$6,000. \$500 is to be spent on sending the church planter/ pastor to an approved church planting seminar. (Proof of attendance is required.) *Any incurred expenses exceeding the \$500 will be the responsibility of the church*. If you have a question about approval for a seminar please call the chairman of the Board of Evangelism.

This fund is solely supported through the denomination-wide fifth Sunday Seeds of Faith offerings. All monies will be sent to the church in care of their Conference Superintendent for presentation to the church. The General Board of Evangelism annually considers applications.
